TERMS AND CONDITIONS

- All stalls will be confirmed against advance of Rs. 5000/- For Hanger B Stalls (A, B, C, G) & Rs. 25,000/- For Hanger A Stalls (D, F), on first come first serve basis. Balance amount must be paid before 31st October 09 failing to which the booking stands cancelled. The booking amount shall not be refunded in the event of cancellation of booking or if participation is withdrawn. We reserve the right to be the final authority in setting any dispute without an arbitrator. In case the event is postponed or cancelled, liability of the organizers is limited to refund of the booking charges paid by the exhibitor.
- As the no. of stalls are limited, organizers reserve the right to accept the offer, on first come first serve basis & also revise the layout and the allotment of the stalls.
- Entry pass & coupons will be issued only after receipt of full payment on or before due date.
- Cheques are subjected to realization for entry/exits to from the exhibition.
- Completed application form should be faxed / couriered by the exhibitor to the organizer at the earliest.
- Space allotted to the approved exhibitor is to be exclusively used by them for display of their exhibits as approved by the organizer. Sub letting of allotted space is not permissible, except in case of Government sponsored / recognized associations with specific approval of the organizer where the space rent, charged by them will not be more than the rate charged by the organizer. Violation of the clause may lead to the cancellation of the space allotted
- The exhibitor shall occupy the space allotted by the time set down by the organizer. In the event of default due to any cause what so ever the exhibitor shall pay to the organizer or further sum in liquidated damages equal to the total charged for the space and the organizer shall have the right to deal with space in any way he thinks best.
- The exhibitor shall not without the written consent of the organizer display, exhibit or bring into the hall any explosives or dangerous material or any such thing which causes noxious fumes or which makes use of display any other against or loss or damage arising out of breach of this cause.
- The organizer can not accept any complaint or claim against it unless it is submitted in written to the organizer within two weeks of the closing date of the exhibition. All claims and disputes shall be settled in the state of Maharashtra in accordance with Maharashtra law & regulations.
- All display advertising exhibits and stand arrangement shall be appropriate to the subject matter of the exhibition in the sole opinion of the organizer shall be tasteful and of suitably high standard and shall not contravene or conflict with any local law, moral or custom and if in the opinion of the organizer the exhibitor is in breach of the cause, the organizer may direct the exhibitor to rectify such breach and the exhibitor shall immediately act accordingly.
- In the event of a breach of any of the conditions herein the organizer may in all cases retain all money paid by the exhibitor and recover further money from the exhibitor as provided herein.
- Any dispute or differences arising out of these terms and conditions of participation shall be referred to the board of the organizer whose decision or award shall be final and binding.
- Participants / Exhibitors are prohibited from using any space, other than that allotted to them. Use of spaces outside the stall, in the side margins and pathways is strictly prohibited. The organizers reserve the right to confiscate any material /goods found to be violating this condition, and causing disturbance to the smooth conduct of the event.
- The terms and conditions of participation shall be subject to the jurisdiction of courts of Pune in the state of Maharashtra.
- **Use of any kind of speakers are not allowed inside the hall.**
- **Force Majeure : In case the event is cancelled or cannot conducted due to conditions not in control of CMDA including but not limited to Act of God, Terrorism, War, Pandemic, Epidemics or restrictions imposed by Local, State or Central Governments or its departments, the liability of CMDA will be only limited to refunding the booking amount collected. CMDA will in no way be liable for any other costs or expenses incurred by the participants. In case of postponement to a later date, the booking amount collected will be considered as a booking amount for the event held at that date, and the same terms and conditions listed will stand valid and accepted.**
